## GROUND REGULATIONS - KINGSMEADOW STADIUM

The club management reserves the right to refuse admission to the ground.

All matches will be played in accordance with the Rules and Regulations of the Football Association, the Football Conference Limited League, the Ryman League and the Laws of the Game.

The club cannot guarantee that a match will take place here at a particular time or on a particular date, although it will make its best efforts to make public any changes to the scheduled programme of first team matches. The club will have no liability in respect of any direct or indirect losses or costs.

In the event of the match being abandoned before half time, the club will offer free admission on the date of the rearranged match. Persons entering the ground are advised to retain their ticket stub, as this will be required to be produced for the issuing of a replacement ticket for the rearranged game. Where a game is abandoned during or after half time the club accepts no obligation to offer free entry to the rearranged match.

Club management reserves the right to refuse admission to the ground, any person who refuses to be searched by any steward, club officer/agent or any police officer. Persons failing to comply with instructions from a steward, police officer or other authorised agent of the club will be in breach of these regulations.

The following actions are considered of breach of the stadium's regulations and are strictly forbidden. The consequences of such breaches are summed up in the final paragraph.

- Bringing into the ground, items such as fireworks, flares, smoke canisters, laser devices, air
  horns, musical instruments, knives, bottles, glass vessels, poles, indeed any article that might be
  used as a weapon and/or might compromise public enjoyment/safety
- Throwing any object within the ground without lawful authority or excuse
- Taking part of chanting of an indecent or racialist nature
- Entry onto the playing area or any adjacent area to which spectators are not generally admitted without lawful authority or excuse
- Banging on the roof of the home or away dugout or any structure
- Spitting onto the playing area of at any persons within the ground
- Persistent standing in seated areas whilst play is in progress
- Moving from the terracing area to the seated area without the permission of a steward, police officer or other authorised club officer/agent
- Obstructing of gangways, access ways, exits and entrances, stairways and like places
- Use of threatening behaviour, foul or abusive language
- Climbing of any structure forming part of the ground
- Smoking in no smoking areas is similarly strictly forbidden
- Unnecessary noise, such as that from the use of radio sets, and behaviour likely to cause confusion or annoyance to any person
- Attempting to enter or being within the ground while being under the influence or in possession of drugs, or intoxicating liquor
- Persons issued with a ticket for a specific seat must occupy that seat unless instructed otherwise by a steward or other authorised officer/agent of the club
- Any person attempting to gain admission to, or being found within, a section of the ground designated as restricted access without the appropriate authorisation

- With the exception of persons authorised by the club management and press representatives
  holding official passes the use of video equipment inside the ground is prohibited. In addition, no
  recording for radio, television or for private purposes, whether for transmission or otherwise, is
  permitted, except with authorisation in writing by the club management
- Only persons specifically authorised in writing by the club's management are permitted to offer for sale or distribute within the ground or on club property any newspaper, periodical or other article
- Any person found damaging or defacing the property of the club

Entering the stadium constitutes acceptance of these rules and regulations and the ground regulations. The club management reserves the right for its stewards, club officers/agents and the police to remove from this ground any person who does not comply with all these rules and regulations, or whose presence within the ground is, or could reasonably be construed as constituting, a source of danger, nuisance or annoyance to any other person. This could lead to further action by the club including, but not limited to, the withdrawal of any season ticket, future suspension, reporting to the police and prosecution.
